## Amazonian Area

### The right to self-determination of indigenous peoples and the right to health

*Peruvian Amazonia*

**Loreto Department, Regional Health Department of Iquitos** and the **Vicariato Apostolico San José del Amazonas**, coordinators M. Francesca Filadoro and Florindo Barisano, for Bilingualism and Training of indigenous masters, Community and Traditional Medicine, construction of 4 Health Facilities and training of local counterparts with vaccination and medical assistance services, titling of native lands for the 25 **Runa** villages of the **Napo River**, the **People of Water**. The native **Association OR.KI.WAN** was supported.

**Huanuco Department, Aucayacu Church, Oblate missionaries**, Father Roberto Carrasco Rojas, to organize a **Comedor Popular** (Popular Canteen) and to provide material, including refrigerators and thermos for anticovid-19 vaccines, also building differentiated covid-19 spaces in the Health Center for both **health personnel and indigenous people in situations of need, vulnerability and social exclusion**.

## Bolivian Amazonia

**Beni Region, Caritas Beni**, director Rosmary Llado and Wilma López responsible of Health Sector in support of the indigenous peoples of the **Movima, Cayubaba, Moré, Canichana, Yura and Mojeña ethnic groups** of the **26** suburban villages of the city of Trinidad, located along the **Mamoré river** through the health activities of the "**Barco de salud Kengo Go**" with monthly river trips, and through annual Surgery Campaigns for children with cleft lip and treatment of specific pathologies in women. For the pandemic, assistance to patients infected with Covid-19 has been strengthened.

## Bolivian Plateau

### The right to eco-sustainable development

#### Cochabamba Department

**Zona Tupuraya, Yachay Tinkuy Center**, in kichwa "Meeting with knowledge", director Elizabeth Saucedo, to promote educating communities by accompanying educators in a personalized and systematic way in 4 educational units in the **peripheral areas** of the city and **rural indigenous communities**, aiming at overcoming the various forms of family, school and community violence.

**Province of Bolivar and Department of Potosì, DESEC partner**, coordinator Davide Blasetti of two international cooperation programs Agro-Zootechnical and Forestry for the development of the rural communities Aymara and Kechwa in the Departments of Cochabamba and Potosì with activities for the conservation of the environment and dynamics of eco-sustainable development, offering technical services of an experimental nature in the intervention sectors, which are still an integral part of the agronomic practices of native communities today.

In the same area, a project of home economics, nutrition and maternal-infant hygiene was carried out in favor of the women of the communities, coordinated by M. Claudia Padilla

## Chile

**Region IX, Temuco, Inproa partner**, director José Nagel, coordinator Marco Moser, in favor of the **Mapuche**, the **People of Land**, for their indigenous and also legislative development to be recognized in the Region and in the Country. The creation of the **Lonko Ketran-Nehuen Mapu Native Association** was supported.

## Argentina

**Arte y Esperanza**, director Mercedes Marsal, and **Amigos de la Patagonia-Friends of Patagonia**, coordinator Sebastian Homps, for activities of **Environmental Education and Forestry** of their Lands for young **Wichi** and **Chanè** of the Province of SALTA, who are studying to be agricultural technicians, in collaboration with Instituto Nacional de Tecnologías Agropecuaria (INTA) de Santa Victoria Este.

## India

### The right to participate in changing one's context

**Karnataka State**, director Nancy Fernandes of the "**Samagratha**" **Itinerant Library Project** (in Sanskrit "solidarity") for 16 rural villages around the city of Honavar, in partnership between the **S.A.R.P.I. Association** (Society for the Advancement of the Rural People of India) and the **Solidarity Libraries Campaign of the Municipality of Rome**.

**Maharashtra State**, coordinator Miranda Paskin of the Hostel Teresian Nivas in **Pune**, to give concrete answers to the needs of **young women of different faiths and cultures**, coming from low-income families and who go to Pune to look for work and keep their studies, trying to achieve economic autonomy and educational growth for the change of their society.

## EAST Europe

### Citizenship rights of children and families with social disadvantage

**Moldova, Municipality of Chişinău partner**, coordinator Paolo Frediani, for the **Creation of an integrated network of Centers for childhood, adolescence and family**, also in partnership with various **Municipalities**, promoting **sustainable community development** and **territorial associations**.

The **local PRODOCS Association** was set up, coordinator Cristina Coroban, for the self-sustainability of the intervention and the involvement of the families of the beneficiaries with their cultural codes.

## Balkan Area, Kosovo

### The right to sustainable development of the territories and local associations

**Gjakova Municipality**, in partnership with the Agriculture Department, to build the **"Butsina Begut" Agro-zootechnical Demonstration Center**, director Imer Feta, aiming at training and technical assistance for farmers to acquire greater skills and means of production, aimed at guaranteeing the improvement of local production and sources of income. Creation of **local ABK Association**.

**Ministry of Agriculture and Zootechnics, Forests, in Peje**, in partnership with the **local Association** of veterinarians **GENKOS**, president Xhavit Bytyçi, and the **PRO.DO.C.S.**' consultant Ugo Cavallini, for the construction of the **1st Kosovo Genetic Center** in a government country program, to support the economic development of rural areas with the recovery of the livestock sector, through the strengthening of the public and private Veterinary Service.
